What is Title I?

- Federal entitlement grant to public schools from US Department of Education.
- Major focus is to provide all children with a fair, equal, and significant opportunity to obtain a high-quality education.
- Title I is defined as "Improving the Academic Achievement of the Disadvantaged".



Purpose of Title I

- Title I is a federal program administered by the states providing supplemental funding to school districts (including charter schools) to assist students deemed "at risk" to meet challenging state academic standards and pass state standardized tests in basic skills, **Math & ELA**
- NJ determines the amount of money to go to each school district based on poverty levels.
- Approximately 50% of New Jersey's schools currently receive Title I funding

CJCP Title I Eligibility for Students 2018-19

- Entrance Criteria
 - Score below expectations on benchmark assessments or tutoring program assessments for ELA and/or Math
 - □ Score Level 1-3 on state standardized test* PARCC in ELA and/or Math
 - □ Recommendation of teacher and/or counselor
- Exit Criteria
 - □ Adequate progress in tutoring program
 - Recommendation of teacher and/or counselor and adequate improvement in class grade for subject
 - □ Passing score on state standardized test

^{*} Other standardized test results are used in the absence of PARCC results.



CJCP Title I Program

- 8th period Tutoring
 - Last period of the day; small groups with our school's teachers
- Extra instructional support, in-class support teachers, provided during regular class time for math and English language arts according to student needs for the class.
